Online June 15, 2024

Gathering

Opening Prayer

Cristi Scott Ligon, co-moderator of the Commission to Unify the Office of the General Assembly and the Presbyterian Mission Agency ("Unification Commission"), called the meeting to order at 3:00 p.m. ET on June 15, 2024, and recognized Ruth Faith Santana-Grace, Co-Moderator, 225th General Assembly (2022), for an opening prayer.

Land Acknowledgment Upon recognition, Cristi Scott Ligon, co-moderator of the Unification Commission, led the land acknowledgment of Trinity Presbyterian Church, Arlington, Va. According to archeologists' estimates, a succession of indigenous peoples occupied the Chesapeake and Tidewater region, arriving roughly 3,000 to 10,000 years ago. Those people of Algonquian and Nacotchtank affiliation who would coalesce into the Piscataway nation, lived in the Potomac (Patawomeck) River drainage area since at least AD 1300. Thanks were given for those who cared for this land and gratitude was given for the land itself.

Agenda and Minutes By common consent and without objection, the Unification Commission adopted the agenda. Some of the materials, including the agenda and materials, were available to the public via EQUIP, a learning management system administered by the Office of the General Assembly. By common consent and without objection, the Unification Commission adopted the minutes of the May 18, 2024, online stated meeting.

Covenant

Cristi Scott Ligon, as co-moderator, read the covenant as a reminder of how the Unification Commission had agreed to engage this responsibility of this commission.

Key Unifying Principles

Cristi Scott Ligon continued by reminding the Unification Commission of their key unifying principles: Relational; Streamlined; Nimble; Justice Focused; and, Vision Driven.

Co-Moderators Report

Felipe Martínez, as co-moderator, provided their report, which included an overview of the preparation for the 226th General Assembly (2024). This included: recording an informational webinar on the work of the Unification Commission for an audience of GA commissioners and mid-council leaders; participating in a webinar on the 2025-2026 Unifying Budget; working with Kelly Beeland, culture and change consultant; and, drafting talking points for Unification Commission members to use at the 226th GA (2024).

Culture Consultant Report

Felipe Martínez, co-moderator, recognized Kelly Beeland for a report, which addressed the work completed since the May 18, 2024, meeting. The work focused on a thorough review of the available materials, focusing on the wants and needs of OGA and PMA. Conversations were held with the Unification Commission co-moderators regarding key themes and challenges to give a comprehensive assessment of current culture and potential challenges to change. These conversations were planned to form the key part of a report to the Unification Commission at the next stated meeting of August 8-9, 2024, intended to be in-person in Louisville, Ky.

Governance Working Group Upon recognition, Debra Avery spoke for the Governance Working Group. A central topic of focus has remained the interim governance and leadership, and this was an intended topic for deep discussion at the in-person August 8-9, 2024, meeting.

Finance Working Group

Upon recognition, Scott Lumsden spoke for the Finance Working Group. Approximately 20 participants joined a webinar led by Scott Lumsden, Dave Davis, and Ian Hall, Chief Financial Officer, Presbyterian Church (U.S.A.) A Corporation, for an overview of the 2025-2026 Unifying Budget.

**Executive Session** 

Upon motion and second, and without discussion, the Unification Commission <u>voted to</u> <u>enter executive session to discuss matters of personnel and property</u>. Staff and guests were invited to remain.

Rising from Executive Session

Cristi Scott Ligon, co-moderator, announced <u>the Unification Commission voted to rise</u> <u>from executive session</u>, and reported the <u>Unification Commission vote to expand the</u> scope of work of Kelly Beeland to include support of additional process planning.

226th GA (2024) Planning Cristi Scott Ligon, co-moderator, recognized Kathy Lueckert, president, Presbyterian Church (U.S.A.), A Corporation, for a discussion on planning for the 226th General Assembly (2024). Kathy Lueckert noted the online committees that may require participation by the Unification Commission include: Financial Resources (2025-2026 Unifying Budget; and, the Special Offerings Report); General Assembly Entity Coordination (Report of the Unification Commission); and, Race, Sexuality, and Gender (expanding support for Latinx Ministries) will be meeting online, with the plenary gathering in Salt Lake City, Utah.

Kerry Rice, Deputy Stated Clerk, Office of the General Assembly, provided an overview between a Resource Person and a Corresponding Member, and the privileges and processes of seeking recognition. For the online committee meetings, it was noted that viewing on three devices was optimal: one to watch the livestream video, one to access PC-Biz (the online credentialed website to handle General Assembly business, including seeking recognition); and, one device to access Zoom, if one was invited to address a committee. It was affirmed that the roles of Resource Person and Corresponding Members had been assigned. Coordination of staffing a resource table during three discreet times was addressed in Salt Lake City, Utah.

### **Governance Workgroup Report**

August 2024

**Summary:** Since the last Commission meeting, our team has focused on developing and revising a draft of an Interim Governance (IntGov) structure. We met weekly for 60-90 minutes with the exception of the two weeks of General Assembly.

Meeting with the PMA Leadership: We met with the Rev. Michelle Hwang and the Rev. Shannan Vance-Ocampo to learn more about the current responsibilities of PMAB. They provided us with information regarding some of the work that will need to be overseen during the interim period. We learned more about the history of the shape and composition of the Board, including how regional representation has historically been managed. We gained more clarity around the review processes the Board undertakes as part of their responsibility to oversee the President/Executive Director. The current work of the board is centered around identifying and focusing on the different forms that the repair of historic harm needs to take. We also gained an understanding of the intersection of PMAB with other boards, committees, and entities as both a human resource need (smaller board means it's harder to fill invitational seats) and a structural matter that is connected to the work of both the Board and PMA.

Meeting with UC Members Representing COGA and PMAB: In order to ensure we had sufficient input regarding the draft of the Interim Governance, we met with two UC members who couldn't attend this August meeting. Dave Davis and Dee Cooper met with us, both in their roles as the representatives of their Committee/Board as well as in their capacity as a UC member. They offered significant input which helped us shape the draft for Interim Governance.

## Finance Workgroup Report // August 2024

Unification Commission Meeting, Louisville, KY

**Good Job Team!:** We continue to be encouraged by the good work that led us up to and through the General Assembly in Salt Lake City. As we embark on some significant work ahead as a commission, it's good to remember that we are indeed up to this unification challenge when we approach this as a team.

**Budget Reductions**: As you are aware, the Unified Budget passed with \$5M in reductions over 2025-2026. With summer schedules in full swing, we have not been able to make much progress on what those reductions will be, but we're hopeful that we'll have a specific recommendation on how to reach this goal by our October meeting. It might be helpful to know that the financial reduction itself may not be the biggest hurdle, but instead establishing a process for evaluating current ministry and program across a unified national church.
